## **IGP Hosts Two U.S. Wheat Asian Milling Courses in October**

IGP hosted two U.S. Wheat Associates courses in October. The Basic Milling Principles for Taiwan course had 10 participants and the Advanced Milling for South Korea course included five participants.

These courses provided students with a better understanding of the flour milling process along with advanced techniques and tools to optimize mill efficiency. Participants had the opportunity to engage in practical, hands-on learning exercises at the Hal Ross Flour Mill and the KSU milling and baking labs in Shellenberger Hall.

Yii Huang, U.S. Wheat Associates Country Director for Taiwan said the opportunity for their industry participants to get time working in the Hal Ross Mill along with the hands-on baking lab exercises using flour from different classes of wheat to bake various products helped them understand the importance

of using high-quality wheat in the milling process to achieve the best results.

Shin Hak (David) Oh, U.S. Wheat Associates Seoul Food/Bakery Technologist, has partnered with IGP to bring several groups from South Korea to attend milling courses. Many participants have commented that the experience improved their results when milling U.S. wheat classes.
